- 1. The current accounts of income and expenses as of 11 Dec. 2019 are attached showing total income for the 2020 Fiscal year of \$31,038.65. Expenses are \$43,537.00 so the operating loss for the first half of the year is \$12,498.35.
- The Brandon Amphitheater project contributed \$13,100 income since July 1. Prior to the beginning of this fiscal year the project had earned \$1,425.00 for a total of \$14,525.00 from parking cars during concerts.
   The State Fair during October was extended another day because of Columbus Day.

Total receipts for the Fair gate over the 13 days were \$355,547.00 according to my

- calculations. The Association earns 3.25% of that for a total earnings of \$11,555.28. The total number of man hours worked exceeds 1625 hours. This total is not confirmed because the check has not been received 60 days later. The total received may also be adjusted by the Fair Commission for any losses incurred.

  4. Annual Memberships received during fiscal year 2020 are \$2,661.70. This included 2019 dues received from July 1 until Oct. 1 when the next year's collections begin. Life
- 5. Eangus dues have been paid in the amount of \$1,034.00. Another check for \$572.00 sent in for Eangus dues has not yet cleared the bank. These amounts include Life Memberships. The reconciliation at the end of November shows our Eangus membership at 7341. Last November, Mississippi's membership was 7533 for a loss of 192 members this 11 months.

- 6. The CPA has almost completed the annual review of our accounts. The IRS filing, the Charities Registration, and financial statements should be available by the end of the month.
