- The current accounts of income and expenses as of 7 September 2021 are attached showing total income for the new Fiscal year of \$12,531.47. Expenses are \$20,951.55 so the operating loss for the year is \$8,420.08.
- 2. The earnings from parking for the first six Brandon Amphitheater events have been received totaling \$5,900.00.
- 3. Interest earnings for this to date are \$1,681.84. The Office Fund Certificate of Deposit matured and was reinvested for 3 years at BanCorpSouth earning only .18%.
- The EANGUS Conference expenses for Albuquerque, NM were \$9,503.91. Forty-Five Registrations for the EANGUS Conference next year in Little Rock were purchased at a cost of \$6,750.00. A refund of \$600 was made for unused registrations.

- 6. Scholarship payments have been mailed to the colleges selected by the winners and all six checks have cleared our bank.
- 7. Association President's coins have been ordered at a cost of \$1,281.00. These coins have been received for distribution at the board meeting.
- 8. The State Fair is the largest, major fund raiser for the NCO Association each year. This allows the programs and scholarships of the Association to continue without an increase in annual membership dues.
