






The House and the Senate announced their Co-Chairs for the National Guard Caucus. EANGUS has a long-standing relationship with both of these Caucuses, and they have proven to be an intricate part of our legislative process.

Bost Urges DoD to Clarify Shifting Policy Impacting GI Bill Eligibility

Rep. Mike Bost (R-IL.), the Ranking Member of the House Committee on Veterans' Affairs, released the following statement after sending a letter to Secretary of Defense, Lloyd J. Austin III, regarding National Guard Members' eligibility for GI Bill benefits following the Biden Administration's recent termination of the national emergency declaration at the southern border.

"The Biden Administration's decision to reverse the emergency declaration at the southern border risks national security. It also risks the education of thousands of members of the National Guard who are still deployed there," said Ranking Member Bost. "Secretary Austin must immediately tell us whether those serving at the border since January 20th are receiving the same credit toward the GI Bill that they were on January 19th. Their service has not changed. Their benefits should not change either. The National Guard has stepped up in extraordinary ways over the last year. They have left their families and lives behind to serve on federal duty at the border, in DC, and elsewhere. Every single one of them should receive full GI Bill credit for their service. I stand ready to work with the Secretary to make sure they get exactly that."

The status of servicemembers of the National Guard currently serving at the southern border includes end strength and the statutory authority for their service. Rep. Bost asked for clarification on whether the rescission of Presidential Proclamation 9844 eliminates the ability for members of the National Guard currently serving on the southern border to continue to receive credit towards Post-9/11 GI Bill benefits and, if so, how that is being communicated to them.

As EANGUS members know, we are continually pushing for our well-deserved benefits. We will continue to monitor this situation and ensure everyone is receiving updated information. We will be assisting Rep. Bost with any follow on legislation he feels is needed.



## Rules to Govern the Conference

## RULES TO GOVERN CONFERENCE

#### EANGUS AUXILIARY AREA IV MID-WINTER CAUCUS

- 1. The governing documents for the 2020 EANGUS Auxiliary Area IV Caucus shall be the Constitution and Bylaws of the EANGUS Auxiliary.
- 2. The presiding officer shall be the Director of the Area who is in the second year of his/her term.
- 3. The Area IV Directors shall appoint persons to serve in the various Caucus Committee capacities deemed necessary to effectively conduct the business of the Area IV Caucus.
- 4. At this Area IV Caucus, the voting body shall consist of each accredited member in attendance.
- "Accredited member" is defined as one who meets the membership and dues qualifications.

- 6. Any member in attendance may speak on a subject under discussion.
- To be recognized, Stand, Address the Chair, Give your name and state.
- 8. A timekeeper shall be appointed by the Area IV Directors for the Caucus. Members are limited to speaking twice on a motion, the second speech being in the nature of a rebuttal or new information on the motion. The mover of the motion is allowed three minutes, other speeches are limited to two minutes, debate to ten minutes.
- 9. A second to a motion must come from a state other than the one which proposed the motion.
- 10. Voting shall be by voice vote, except in the event of an undetermined vote and then voting shall be by ballot.
- 11. The election of the Secretary and Treasurer for EANGUS Auxiliary Area IV shall be held biannually at the Area IV Caucus preceding the EANGUS Auxiliary Conference at which the election of EANGUS Auxiliary officers is held... even years—2016, 2018, 2020, etc.
- 12. Robert's Rules of Order, Newly Revised, shall be the Parliamentary authority except where it is in conflict with the EANGUS Auxiliary Constitution, or with standing or special rules established by a General or Special Conference.

### Roll Call of the States

Secretary Vivian Taylor recorded attendance from the states. States and members in attendance were: Kansas, 5 (Amanda Wilwert-Bradley, Delores Edwards, Andrea Holt, Judith Putman, and Sandy Sadowski); Mississippi, 3 (Paula Carrigan, Connie Myers, and Vivian Taylor). There were no attendees from Arkansas, Louisiana, Missouri, Oklahoma, and Texas. A sympathy card was signed for Trayce Young (AR) whose father had died January 04, 2022.

## Approval of the Auxiliary Minutes from the 2020 Mid-Winter Caucus

Secretary Vivian Taylor provided the minutes to all attendees via email in January 2020; minutes were distributed again via email by Director Putman in January 2022. Connie Myers (MS) moved the minutes be accepted as published; Amanda Wilwert-Bradley (KS) seconded the motion. Minutes were approved as published.

## State Reports

Kansas—President Sandy Sadowski highlighted items from the printed report.

Current officers for Kansas Auxiliary—Sandy Sadowski, President; Amanda Wilwert-Bradley, Vice President; Andrea Holt, Treasurer; Judith Putman, Secretary.

Area IV Mid-Winter—The 2021 Mid-Winter was a virtual meeting due to COVID. Judith Putman was in attendance as the EANGUS Area IV Auxiliary Director.

State Conference—The Annual Kansas National Guard Joint Conference met virtually on Saturday, April 17, 2021. The Auxiliary meeting was led by President Sandy Sadowski. Members in attendance were Andrea Holt, Judith Putman, Sandy Sadowski, and Amanda Wilwert-Bradley. The Treasurer's Report was made available through email by Andrea Holt, Treasurer. The following balances were reported: General Fund \$3,855.20; Scholarship Fund, \$1,381.42; Hospitality Fund, \$570.10; total balance in checking, \$5,806.72. The report was accepted. Members agreed to make the annual donation of one hundred dollars (\$100.00) for 2021 to EANGUS "We Care for America" at the EANGUS Auxiliary Conference. The Auxiliary continued to fund its scholarship programs with annual Silent Auctions which were held at the state conferences. Kansas was unable to hold these events during the state conferences since the 2020 conference was cancelled and the 2021 conference was virtual. There was an Enlisted Association of the National Guard of Kansas (EANGKS) State Conference golf tournament scheduled for May 28, 2021, and the Auxiliary made plans to prepare several gift baskets to have available at the tournament for a silent auction. Scholarship Committee—Information was emailed out to the members for the year's scholarships on March 8. Lynn Holt, scholarship chair, reported he had not received any applications as of April 17. Decision was made to resend an email to remind members to get qualified applicants to submit their applications. Members asked that the Auxiliary President gather information for an email to go out to the members on how and when to apply for the EANGUS Auxiliary's scholarships. The EANGKS Auxiliary awarded one scholarship in the 2021 year for five hundred dollars (\$500.00); the recipient was Delani Nichols, granddaughter of Carol Roush. Legislative Committee—The President would forward the Legislative "Calls to Action" emails to both Auxiliary and Associate members, with an added note instructing members to report their participation in contacting legislators using VoterVoice or any other method to the Kansas Auxiliary Legislative Chair, Judith Putman, at <u>ilputman@hotmail.com</u>.

Fundraiser—Those in attendance on May 28, 2021 for the EANGKS State Conference Golf Tournament enjoyed a great time. The Auxiliary auctioned off several baskets at the event and raised six hundred sixty-eight dollars (\$668.00) for the Auxiliary scholarship fund.

EANGUS/Auxiliary Conference—The EANGUS/Auxiliary Conference was held August 8-12, 2021 in Albuquerque, New Mexico. Five (5) Kansas Auxiliary members attended: Amanda Wilwert-Bradley, Andrea Holt, Judith Putman, Judy Smith, and Sandra Sadowski. Andrea Holt served on the EANGUS Auxiliary Finance Committee. Andrea Holt's

name was drawn in the membership drawing held for those who had recruited members; she received a Walmart gift card. Amanda Wilwert-Bradley was recognized as a first-time attendee. Those who were recognized and presented with certificates for their legislative efforts: Judith Putman for 2019-2020 and Andrea and Lynn Holt for 2020-2021. Judith Putman was recognized for winning the EANGUS "The Pen Is Mightier Than the Musket" Award for 2020 and the EANGUS Auxiliary Area Director of the Year Award for 2021. The Kansas Auxiliary donated one hundred dollars (\$100.00) to the EANGUS "We Care for America" Foundation, Inc. Those who attended the EANGUS/Auxiliary Conference enjoyed the fellowship, great entertainment, wonderful food, and attending all the meetings. Members were looking forward to the 2022 EANGUS/Auxiliary Conference to be held in Little Rock, Arkansas.

Deceased Lifetime Members—Two Kansas lifetime members were memorialized at the 2021 EANGUS Auxiliary Conference: Jo Kinzie died February 21, 2020 and Ruth Stoops died November 03, 2020.

<u>Mississippi</u>—President Connie Myers highlighted items from the printed report.

State Conference—The 2021 MS NG NCO Association/Auxiliary State Conference was held at Camp Shelby April 23-25. The Mississippi Auxiliary Past Presidents Breakfast was held in the All Ranks Club on Friday morning, with seven (7) Mississippi Auxiliary Past Presidents present: Pat Burchfield, Paula Carrigan, Billie Davis, Danna Davis, Ann Hart, Connie Myers, and Vivian Taylor. Connie Myers spoke to the joint session on Saturday morning and then the Auxiliary held its annual general session. Reports were given and a budget was approved. There were no eligible scholarship alternates for 2021.

Area IV Mid-Winter Caucus—The 2021 Area IV Mid-Winter Caucus was held via Zoom in January. Mississippi Auxiliary members Connie Myers and Vivian Taylor joined in the meeting.

EANGUS Conference—The 50th Anniversary EANGUS/48th EANGUS Auxiliary Conference was held August 8-11 in Albuquerque, New Mexico. Vivian Taylor served as EANGUS Auxiliary Secretary and Connie Myers served as EANGUS Auxiliary Immediate Past President. Mississippi Auxiliary Past President and Treasurer Pat Burchfield served as a delegate and the Mississippi Auxiliary answered roll call with one delegate and seven proxies. Mississippi youth Lindsey Higginbotham received the EANGUS Auxiliary two thousand dollars (\$2,000.00) scholarship. Mississippi Auxiliary District Director Elaine P. Jackson received the EANGUS Auxiliary Distinguished Service Award. Mississippi Auxiliary received the EANGUS Auxiliary Outstanding State Award in the 76 plus members category. Mississippi Auxiliary received recognitions for membership growth in the 76 members category for 2020: largest percentage increase in total members; largest percentage increase in lifetime members; largest percentage increase in associate members; largest increase in total members; largest increase in lifetime members; and largest increase in associate members. Vivian and Jerry Taylor received certificates for legislative efforts in 2020 and 2021. Secretary Taylor received the EANGUS Auxiliary President's Award and the EANGUS Auxiliary Recruiter of the Year Award. Mississippi nominated Judith Putman for the EANGUS Auxiliary Outstanding Area Director Award, James "Jim" Rains for EANGUS Auxiliary Spouse of the Year Award, and Frank Yoakum for the EANGUS Auxiliary Meritorious Service Award; each of those individuals received the award for which she/he was nominated. The Mississippi Auxiliary donated three hundred dollars (\$300.00) to the EANGUS Auxiliary philanthropic project; in 2021 Fisher House in Albuquerque was the recipient of those funds.

Newsletter—Six (6) issues of the *Mississippi Strong* newsletter were published in 2021. *Mississippi Strong* received First Place tie from EANGUS in the Auxiliary State Newsletters category. The MS Auxiliary newsletter as well as the EANGUS Auxiliary newsletter were posted on the MS NG NCO Association website.

Communication—In addition to the newsletter, MS Auxiliary Officers contacted members through email and Facebook. All EANGUS Auxiliary and EANGUS communications, as well as EANGUS/Auxiliary Area IV communications, were forwarded to members.

Legislative—Over twenty members continued to respond to the EANGUS Calls to Action. The Legislative Committee Chairman reported activity to the EANGUS Area IV Auxiliary Legislative Point of Contact with courtesy copies to the EANGUS Auxiliary Officers. Mississippi Auxiliary Secretary Vivian Taylor nominated EANGUS Area IV Auxiliary Director Judith Putman for the 2020 EANGUS "Pen Is Mightier Than the Musket Award" and Judith was the recipient of that award. Since the EANGUS Conference had been cancelled in 2020 it had been anticipated that the award would be presented at the EANGUS Area IV Mid-Winter Caucus. Since that meeting was held only by Zoom the award was presented to Judith at the 2021 EANGUS Auxiliary Conference.

**Projects/Participation**—Members donated three hundred fifty dollars (\$350.00) to the EANGUS "We Care for America" Foundation, Inc. Members worked with the MS NG NCO Association on its Ways and Means project, the Mississippi State Fair. The Association shared a portion of its proceeds with the Auxiliary. Association and Auxiliary members, as well as Telephone Pioneers (that organization gave one thousand dollars' worth of items), in cooperation

with 5<sup>th</sup> Squad, made a huge donation in 2021 to the Mississippi Veterans Homes. The car loads of items donated included T-shirts, underwear, socks, puzzles, games, hygiene items, and seven hundred dollars (\$700.00).



# Army Private James S. Bumgarner's sense of smell saved the day during the Korean War

James Garner started his Army career in the California National Guard before joining the Regular Army during the Korean War. He served with the 5th Regimental Combat Team in combat where he was wounded twice and awarded two Purple Hearts. In his

2011 memoir, The Garner Files, he wrote: *Army chow was bearable as long as I could keep the onions and garlic out of it. I cannot stand onions and I'm very sensitive to garlic. I can taste tiny amounts of it, like when they've cooked another dish with garlic before and don't wash the pan. If I get even a hint of it, I might throw up in my plate. This violent aversion may have saved my life: like our South Korean allies, the Chinese and North Korean troops lived on a diet of fish heads, rice, and garlic. One night while on guard on the line, I caught a faint whiff of it coming from the direction of the enemy positions. I couldn't see anything, but I knew there was someone out there and they were coming closer. Once I sniffed them I could hear them, too. It turned out to be a patrol heading straight for our position. They were just the other side of a rise when I passed the word down the line. We were ready for them and stopped them in their tracks. He was wounded in that exchange and received his first Purple Heart. His second Purple Heart was received for being wounded during a friendly fire incident where a strafing fighter hit him in the buttocks. "I got it in the backside. I went into a foxhole headfirst and I was a little late. There's a lot of room for error with a wound in the rear. It's a wide target."*



Reference: Scholarship Rules

The Scholarship Committee of EANGUS Auxiliary is accepting applications for the school year 2022-2023. If funds are available, one USAA scholarship in the amount of \$3,000.00 will be awarded to the number one ranked applicant; one EANGUS Auxiliary Scholarship in the amount of \$2,000.00 will be awarded to the number two ranked applicant; one EANGUS Auxiliary Scholarship in the amount of \$1,500.00 will be awarded to the third ranked applicant; the fourth a n d fifth ranked applicants will receive \$1,000.00 each.

- 1. Please read materials carefully before giving any applications to candidates. Be prepared to give assistance if needed. No previous recipients are allowed to apply again.
- 2. In order for each application to be considered, it MUST contain the following documentation NO EXCEPTIONS.
  - a. Official High School/College Transcripts.
  - b. Signed and dated letter from Applicant containing future goals and need for assistance. The letter must not be less than three hundred fifty (350) words and not to exceed five hundred (500) words.
  - c. A Letter of Recommendation and Transmittal from the State Auxiliary President, Scholarship Chairperson or Designee indicating that the application is in order and has all documentation.
  - 3. EANGUS Auxiliary sponsor must have dues paid to National Auxiliary no later than December 31, 2021.
  - 4. For applicants to be eligible, sponsor's State Auxiliary must make a donation to the EANGUS Auxiliary Scholarship Fund for the current and prior year. (Mandatory donation is \$2.00 per member annually payable by December 31.)

It will be the responsibility of each State to make the information available to their membership. You may copy the application, however, DO NOT reduce it. Each State is to designate a Scholarship Chairperson and the applications returned to that person by a specific date. The application should then be reviewed to ensure all requirements have been met. Any incorrect applications received by the National Committee will be considered ineligible.

The Enlisted Association of the National Guard of the United States Auxiliary Scholarship Awards Program is as follows:

The following persons are eligible:

- 1. EANGUS Auxiliary Members
- 2. Unmarried, children/step children, grandchildren/step grandchildren, up to age 26, of Annual and Life EANGUS Auxiliary Members.
- 3. Spouses of EANGUS Auxiliary Members

Verification of membership in the EANGUS Auxiliary of the mother, father, step mother/father, grandparents/step grandparents, spouse or self is necessary for applicants to be eligible.

For applicants to be eligible, sponsor's State Auxiliary must have made a donation to the EANGUS Auxiliary Scholarship fund for the current year and the prior year. (Mandatory amount is \$2.00 per member per year payable by 31 December.)

Applicants must be enrolled at a university, college, business or trade school taking a minimum of eight accredited hours. \*\*Graduate students are not eligible\*\*.

An alternate recipient will be selected in case a recipient is unable to accept the award.

There shall be no consideration whatsoever given by the judges because of rank or grade of applicant, applicant's parents/step parents, grandparents/step grandparents or applicant's spouse.

Scholarships will be awarded on the basis of scholastic achievement, character, leadership and need. All applications must be accompanied by the following documentation:

- 1. An official transcript of high school credits and/or college credits for applicants already enrolled in institutions of higher learning.
- 2. Signed and dated letter from applicant with specific goals to continue his/her education and why financial aid is required, not less than three hundred fifty (350) words and not to exceed five hundred (500) words.
- 3. A letter of recommendation and transmittal from State Auxiliary President, Scholarship Chairperson or Designee.

Checks will be sent directly to the recipient, made payable to the institution of the recipient's choice, when verification of current enrollment is received by the committee chairperson.

These are one-time awards and shall not be repeated. Non-recipients may reapply so long as stated requirements are met. If the school term is not completed, due to cause other than sickness or injury, the student will refund the scholarship award in full to the EANGUS Auxiliary.

Scholarships will be awarded on the basis of funds availability for the current year and the number of applicants.
